

**Goochland County Republican Committee**  
**2020 Mass Meeting Call**  
**Approved February 19, 2020**

I, John D. Myers, Chairman of the Goochland County Republican Committee (GCRC) of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended by the Committee, do hereby issue a Call for a Mass Meeting to be held at Goochland High School, 3250-A River Road W., Goochland, VA 23063, or its alternative location, on Saturday, March 28, 2020, for the purpose of:

1. Electing GCRC officers for the two-year term of 2020-2021, and
2. Electing GCRC members for the two-year term of 2020-2021, and
3. Electing delegates to the Seventh District Republican Convention to be held at the Arthur Ashe Junior Athletic Center, 3001 N. Arthur Ashe Blvd., Richmond, VA 23230, or its alternate location on Saturday, April 25, 2020, and
4. Electing delegates to the Republican Party of Virginia Quadrennial Convention to be held at the Greater Richmond Convention Center, 403 N. Third St, Richmond, VA, 23219 or its alternate location on May 1-2, 2020, and
5. Consideration of resolutions properly submitted by the established filing deadline.

The Mass Meeting will commence at 10:30 AM. Registration shall be open from 8:30 AM until 10:15 AM.

**Qualifications for Participation in the Goochland County Mass Meeting:** All legal and qualified voters of Goochland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the November 3, 2020 election may, as members of the Republican Party of Virginia, be elected as delegates or alternate delegates to this Mass Meeting, subject to the provisions in Article I of the Plan of Organization of the Republican Party of Virginia.

Delegates and alternate delegates must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

**Registration Fee:** Participants may pay a voluntary registration fee of \$25.00.

### Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H, items 6-8 of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia (<https://virginia.gop/rpv-convention/>).

**Mass Meeting Filing Requirements:** All Republicans wishing to pre-file to participate in the 2020 Goochland County Republican Mass Meeting, must file the Combined Application/Registration Form and submit it by U.S. Mail or in person to John D. Myers, 4361 Shannon Hill Road, Columbia, VA 23038 or email to [chemist44@centurylink.net](mailto:chemist44@centurylink.net) by Wednesday, March 18, 2020 8:30 PM. Postmarks will not be considered. All others must file during the Mass Meeting registration period, 8:30 AM – 10:15 AM Saturday, March 28, 2020.

**Goochland County Republican Committee (GCRC) Membership Requirements:** All persons requesting to be considered for membership in the GCRC must be registered voters in Goochland County and be in accord with the principles of the Republican Party. Applicants must submit the Combined Application/Registration Form accompanied by the \$30.00 annual membership fee by Wednesday, March 18, 2020 8:30 PM. Postmarks will not be considered. All others must file during the Mass Meeting registration period, 8:30 AM – 10:15 AM Saturday, March 28, 2020. Checks shall be made payable to GCRC.

**GCRC Officer Candidate Filing Requirements:** Any candidate for Chairman, First Vice Chairman, Second Vice Chairman, Treasurer, and Secretary of the GCRC must submit the Combined Application/Registration Form along with the filing fee, by postal mail, or in person, which includes full name, mailing address and phone number, to John D. Myers, 4361 Shannon Hill Road, Columbia, VA 23038 or email to [chemist44@centurylink.net](mailto:chemist44@centurylink.net), and must be received no later than Wednesday, March 18, 2020, 8:30 PM. Postmarks will not be considered. The filing fee shall be \$50.00. Checks shall be made payable to GCRC.

**Seventh Congressional District Delegate Filing Requirements:** All Republicans wishing to be Delegates to the Seventh Congressional District Convention must file the Combined Application/Registration Form and submit it to John D. Myers, 4361 Shannon Hill Road, Columbia, VA, 23038, along with the filing fee no later than Wednesday, March 18, 2020, 8:30 PM. All others must file during the Mass Meeting registration period, 8:30 AM – 10:15 AM Saturday, March 28, 2020. Postmarks will not be considered.

The voluntary registration fee is \$25.00 Any delegate who fails to pay the registration fee may participate only in the nomination of candidates for public office (which are the nominees for Congress and the Elector). Checks shall be made payable to GCRC.

**Republican Party of Virginia 2020 Quadrennial Convention Delegate Filing Requirements:** Republicans wishing to be delegates to the RPV 2020 Quadrennial Convention must complete the Combined Application/Registration form and submit it to John D. Myers, 4361 Shannon Hill Road, Columbia, VA 23038 or email to [chemist44@centurylink.net](mailto:chemist44@centurylink.net) along with filing fee by Wednesday, March 18, 2020, 8:30 PM. All others must file during the Mass Meeting registration period, 8:30 AM – 10:15 AM Saturday, March 28, 2020. Postmarks will not be considered.

To assist the operations of the Republican Party of Virginia in supporting unit mass meetings and conventions, and the administration of the state Convention, a voluntary Delegate Registration Fee of Thirty-Five Dollars (\$35.00) is requested of each person standing for election as a delegate or alternate delegate to the state Convention. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll. Checks shall be made payable to GCRC.

**Resolutions of the Goochland County Republican Party:** All resolutions must be submitted to the GCRC Chair by postal mail, in person, or by electronic mail which includes full name, mailing address and phone number of the person submitting the resolution, to John D. Myers, 4361 Shannon Hill Road, Columbia, VA 23038, [chemist44@centurylink.net](mailto:chemist44@centurylink.net) and must be received no later than Wednesday, March 18, 2020, 8:30 PM. Postmarks will not be considered. If no resolutions are received by the filing deadline, a Resolutions Committee Chair and Committee will not be appointed at the Mass Meeting.

**Conduct of the Mass Meeting:** The meeting will be conducted in accordance with the Code of Virginia, the Republican State Party Plan of Organization, this Call, and Robert's Rules of Order Newly Revised, in that order of precedence. Nominations from the floor for any office will not be accepted, however, if no individual has properly prefiled for one of the offices of the GCRC, nominations for such office may be entertained at the Mass Meeting from the floor.

**Mass Meeting Committees:** The GCRC Chair shall appoint the chairman and members of a Credentials Committee, a Nominating Committee, a Rules Committee, and a Resolutions Committee.
