

Message from Chairman John D. Myers

I ALIENATE PEOPLE

CRITICAL RACE THEORY – WHAT IT IS

There is no course, textbook or curricula named “Critical Race Theory” (CRT) in any school division in Virginia. Instead, CRT is a worldview that proposes to divide us by class and race and by the oppressed vs. the oppressors. A TON of information has been published on CRT and Hilldale College’s recent *Imprimis* article is one of the best in my opinion.

[Hillsdale College](#) is hardly a right-wing conspiracy institution. They are a classically liberal Christian university founded 170 years ago with a mission of learning, character, faith, and freedom.

Here’s an excerpt from their CRT article:

[Copied from the Hillsdale College *Imprimis* dated March 2021]

“Critical race theory is an academic discipline, formulated in the 1990s, built on the intellectual framework of identity-based Marxism. Relegated for many years to universities and obscure academic journals, over the past decade it has increasingly become the default ideology in our public institutions. It has been injected into government agencies, public school systems, teacher training programs, and corporate human resources departments in the form of diversity training programs, human resources modules, public policy frameworks, and school curricula.

There are a series of euphemisms deployed by its supporters to describe critical race theory, including ‘equity’, ‘social justice’, ‘diversity and inclusion’, and ‘culturally responsive teaching’.

Critical race theorists, masters of language construction, realize that ‘neo-Marxism’ would be a hard sell. *Equity*, on the other hand, sounds non-threatening and is easily confused with the American principle of *equality*. But the distinction is vast and important. Indeed, equality – the principle proclaimed in the Declaration of Independence, defended in the Civil War, and codified into law with the 14th and 15th Amendments, the Civil Rights Act of 1964, and the Voting Rights Act of 1965 – is explicitly rejected by critical race theorists. To them, equality represents ‘mere nondiscrimination’ and provides ‘camouflage’ for white supremacy, patriarchy, and oppression.”

HAS OUR SCHOOL DIVISION ADOPTED CRT POLICIES?

This is tricky to determine, and it takes work because CRT concepts tend to become imbedded into policies and programs over time. There is no Virginia state law that requires CRT be taught in our schools, rather, the very liberal Northam-appointed Department of Education has interwoven CRT concepts into guidance documents, policies, and memorandums. It is our job to help our school division recognize and eliminate these concepts from Goochland County Public Schools (GCPS).

Because we will not find CRT specifically mentioned in any school policy or curriculum, or even in the Standards of Learning (SOLs), we should review school policies for words such as equity, social justice, diversity, inclusion, and culturally responsive teaching. What is the GCPS EdEquity policy? We should ask what teachers are being taught. We should ask how our school division is monitoring teachers to prevent them from continuing to introduce CRT concepts into their classrooms. We should ask our school division to clearly state their position on CRT.

We should immediately report all incidences of CRT language or concepts being introduced into our classrooms to the Superintendent and School Board members. We should attend School Board meetings and correspond with our School Board members.

You are encouraged to stay engaged in our public-school division. We have the right and the duty to ask questions of our elected School Board members and our students have the right not to be indoctrinated with this destructive philosophy. Even if you do not have children or grandchildren in our schools, remember that 40 cents of every tax dollar you send to Goochland County is spent on education.

- Absentee ballots will no longer need a witness' signature **during a public health emergency**.

Plenty of people would claim this a conspiracy theory, but the evidence is mounting that banks are discriminating against conservatives. Back in 2019, some conservative activists were “debanked” by JP Morgan Chase. If you the read the article, it’s really not clear what happened and there certainly could be more to the story. Then in June 2021 two outspoken conservatives had their accounts arbitrarily closed by Wells Fargo. This time it was Christian conservative speaker and former Republican senatorial candidate Lauren Witzke and Pete D’Abrosca, columnist at the conservative news source *American Greatness*. In July, they did it again to Andrew Torba. BB&T (merged now with SunTrust) seemingly cancelled Torba’s account for no reasons other than political. “This decision is not based on credit reporting information or any other considerations related to your credit,” the letter read. “We have made this decision because some or all of your account activity is not consistent with the intended purpose of the account,” confirming that they had they right to close any account at any time at their discretion. <https://thebeltwayreport.com/2021/07/breaking-banks-close-accounts-of-big-techs-1-threat/>
