### ATTORNEY GENERAL MIYARES' STATEMENT REGARDING THE THREAT TO CATHOLIC MASSES THIS SUNDAY

RICHMOND, VA -- Attorney General Jason Miyares issued the following statement regarding the threats of protestors disrupting Catholic masses this Sunday.

"Some on the extreme left have responded to this week's reprehensible leak of a draft Supreme Court opinion by calling for pro-abortion protests inside and outside of Catholic parishes this Sunday.

"I deeply respect the First Amendment rights of speech and assembly. But no one has the right to interfere with the fundamental and natural right of all Virginians to practice their religion in peace.

"Virginia's long tradition of protecting religious liberty dates back to the founding of our Commonwealth, when Thomas Jefferson penned the Virginia Statute for Religious Freedom that is now enshrined in our Commonwealth's Constitution.

"As Attorney General, I am charged with protecting this sacred right for all Virginians.

"Federal law makes it a felony to intimidate, interfere with, or obstruct any person who is seeking to exercise his or her First Amendment right of religious freedom at a place of religious worship. Similarly, Virginia criminal law prohibits obstructing the free movement of other persons, trespassing on church property, or obstructing proper ingress to and egress from a church. My office will be monitoring protest activities directed at houses of worship and will refer alleged criminal violations to the United States Department of Justice or to the appropriate Commonwealth's Attorney.

"Furthermore, federal law authorizes states to bring civil suits to protect their citizens' free exercise of religion. If protest activities directed at houses of worship cross the line to illegal obstruction, intimidation, or interference, I will not hesitate to bring suit to protect the religious freedom of the citizens of this Commonwealth."

### Bullet pierces window of Virginia attorney general's office

A bullet that pierced the sixth-floor window of the [Virginia](#) attorney general's office in Richmond is being investigated by state Capitol Police. [Police](#) were notified Monday evening about a bullet on the sixth floor of the Barbara Johns Building, where a small round hole was discovered at the top of a window, police spokesman Joe Macenka told the [Washington Examiner](#).

"There is no indication that this incident was targeted at the OAG specifically or any individual employee," Chief Deputy Attorney General Chuck Slempl told the attorney general's office in an email.

Housekeeping staff found the bullet on the sixth floor, where the attorney general and other state officials have their offices, the attorney general's office said, [according to WRIC](#).

## Congressman Good Issues Official Statement on House Vote to provide additional \$40 Billion to Ukraine

**WASHINGTON, D.C.** – Today, Congressman Bob Good (R-VA) issued the following statement on the United States House of Representatives vote to provide an additional \$40 billion in foreign aid to Ukraine.

"Rather than outlining a long-term strategy toward the Russian war against Ukraine or passing legislation to unleash American energy to undermine Russian influence in Europe, House Democrats are rushing through another \$40 billion in spending. This vote not only triples down on the recent \$14 billion aid package Congress approved for Ukraine just two months ago, but Speaker Pelosi gave us just six hours to review how this \$40 billion will be spent before voting on it. Once again, the Democrats rammed through an unpaid-for spending bill with no substantial time for Congressional deliberation and no opportunity to amend it.

"This bill is a reminder of the Biden-Pelosi America-last agenda. Democrats are ignoring the many crises plaguing our country, including family budget-busting inflation, supply chain shortages for baby formula and other essentials, surging violent crime in our cities, and millions of illegals trafficking across our Southern Border. The House has now passed \$54 billion for Ukraine, while our Customs and Border Patrol operates on an annual budget of only \$4.9 billion dollars, and our Immigrations and Customs Enforcement agency operates on an annual budget of merely \$8 billion dollars.

"Simply throwing money we don't have at every problem is not a winning strategy. But, this is always the Biden-Pelosi game plan. In fact, every member of Congress should expect another more expensive Ukraine spending package to follow."

## Victor J. "Vic" Carpenter Selected as Goochland County Administrator

The Goochland County Board of Supervisors voted at its May 3rd meeting that Victor J. "Vic" Carpenter will be the county's next County Administrator.

Carpenter will begin his duties as County Administrator effective June 20, 2022, succeeding Manuel "Manny" Alvarez, Jr. who has served as Interim County Administrator since August 2021.

Carpenter is currently the County Administrator for Kershaw County, South Carolina with more than 25 years of local government experience. Carpenter has served as President of the SC Managers, Administrators and Supervisors Association and has been actively involved in his community through Rotary International, Kiwanis and as President of the Boys and Girls Club. He previously led his county to receive the All-America City Award, oversaw the construction of numerous buildings and managed record fund balances as well as effectively used excess fund balances to provide needed capital upgrades for the county.



Carpenter's career has taken him from urban counties along the I-85 corridor to small rural counties. He has developed a reputation of being community oriented. His endorsements range from the NAACP to the American Legion, and his legacy of community improvements range from new Humane Society animal shelters to new Farmers Markets. He has overseen construction of library buildings, upgrades to county courthouses, educational facilities, recreational complexes, and public works facilities.


