

If you're proud of your race as a minority, but hate white people for theirs...


Congratulations. You're a racist.


The Golden Triangle of Freedom

In 1831, a French historian and political thinker named Alexis De Tocqueville visited the United States to try and understand, firsthand, what had enabled the young Republic to grow and flourish as much as it had in its first roughly 50 years. Upon his return to Europe, he wrote his classic work, "Democracy in America". A quote that is misattributed to de Tocqueville sums up his conclusion: "Not until I went into the churches of America and heard her pulpits aflame with righteousness, did I understand the secret of her genius and power. America is great because she is good, and if America ever ceases to be good, she will cease to be great".

Reading those words today could cause many to shudder, I would think. It's hard to imagine churches with "pulpits aflame" these days as there are reports of many churches closing their doors due to lack of a sufficient congregation. On top of that, Covid taught us that our government felt ABC stores were more important to the people than religion.

The British Historian, Os Guinness, in his 2012 book titled, "A Free People's Suicide" explains the essential foundation of our government of the people, by the people, for the people. His name for it is the Golden Triangle of Freedom. In essence, the Golden Triangle surmises that freedom requires virtue, virtue requires faith and faith requires freedom. There are numerous quotes from our founders, too many to list, that support that first leg of the triangle such as Benjamin Franklin's, "Only a virtuous people are capable of freedom" and John Adam's, "The only foundation of a free Constitution is pure virtue". When de Tocqueville visited many years later, he saw plainly that the secret of American freedom was American virtue. Not an inherent virtue, but a virtue that was a deep-seated part of the American culture at that time.



What then of the second leg of the triangle, virtue requires faith? John Adams said, "Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other". He understood that the key to self-government was that the people themselves must be capable of self-governing. For this to be the case, morality was necessary. But notice that Adams says a moral *and religious* people. For Adams and most of the founders and American citizens at that time, religion was a necessary component to the success of the new Republic. In that time, religion, some form of Christianity in most cases, was a given! From the writings and quotes attributable to the Founders, the large majority of them could not have foreseen a future where American citizens would not comprehend this, but in fact, actually argue against it. If asked the question, what would cause someone to act virtuously, our Founders would have said it was religion. And when de Tocqueville came to visit, he observed it to still be so as he said, "In France, I had

almost always seen the spirit of religion and the spirit of freedom marching in different directions. But in America, I found they were intimately united, and they reigned in common over the same country".

Almost unanimously, the Founders felt that virtue was necessary to freedom and religion/faith was necessary to virtue. So, what was it that enabled religion to thrive in America as it did? According to Guinness, that was Freedom! As you look around America today, you would be hard pressed to say that we have anywhere near the freedoms that Americans of the 1800's had. Just look at the countless laws and regulations and taxes that we are all subject to. A day doesn't go by that we don't hear about a random mass shooting such as the Nashville shooting just days ago or watch a video of a random attack by mobs on innocent bystanders or the ambush of police. It would be hard to disagree the virtue that was so prevalent in American society during our first 50 – 100 years and upon which our Constitution is based, has taken leave of many of our citizens. It would be hard to argue that taking God and religion out of our schools, public buildings and arenas many decades ago hasn't been a factor in virtue's demise.

America was great because we were good. We certainly are not good at this time and in fact are in a pretty steep decline in multiple ways. However, we can be great again. We just must get around to being good again. And fast!

Campaigning in Virginia...is it the Money or the Message that Wins? OR IS IT A MATTER OF THE VOTES VS BALLOTS?

The cost of legislative races in Virginia has more than tripled in the last twenty years. When adjusted for inflation, in 1999 the aggregate spent for the campaigns was \$38.9 million. By 2019 it was \$134.8 million. The cost of gubernatorial races rose from \$58.4 million in 2001 to nearly \$188 million in 2021, when adjusted for inflation. So, if you want to represent Virginians, you better have some cash cow behind you.

As most people know, Virginia law does not limit the amount of money donated to candidates and political action committees. The same is true for only three other states: Nebraska, Oregon, and Utah. Virginians running for federal office are held to limits on campaign donations. There has been legislation proposed to change this.

So, who was the largest political donor in Virginia for 2020-2021? According to VPAP, that would be our governor, Glenn Youngkin. Highest donor in the state = highest position in the state. Now, it's all fine when our guy wins. But it's not fine as a matter of principle. It stinks. And why should

anyone have to give up so much personal wealth to run for office? This while McAuliffe was raking in millions

from other states for his campaign against Youngkin. I'd argue that the intent of Virginia government is for only the constituents to have an interest in who is representing them. So, shouldn't only be the constituents who help fund the campaigns.

Typically, in Virginia, Dominion Energy is one of the top donors. Then there's the donor, Michael Bills in Charlottesville who decided to take them on. He's an environmentalist hell bent on solar and wind power. It's no wonder Virginia has California style legislation for the green energy, including no gas car sales by 2030. All because some rich guy whose money-gaming in the climate scam decides to fund candidates who will pay him back in legislation. It's a solid strategy. In fact, maybe it's a more powerful position to be a mega donor than a politician if you want to affect legislation in Virginia.

So, we have a dumb situation here now where we're expecting our legislators who are playing this game to actually work to change it. Is that not the fox watching the hen house? They're already beholden to their donors, and they've worked hard to master the system if they're now in office. It's stacked against the people from the private sector because developing the contacts and deals to garner the financial support leads to career politicians and political power for the very wealthy who fund them without limits.

But is money everything? A lot of money but a lack-luster candidate or campaign won't get people off their couch to vote. Little money but a creative impactful message, and you get free promotion from engaged constituents talking politics, forwarding social media, and organically spreading of the word. That is, if there's not censorship from the powers that be in our government's collusion with media. There clearly is censorship so the only organic spreading of the word is by word of mouth. So, know your facts and use your mouth every chance you get.

And about those people not motivated enough by a campaign message to get off their couch to vote...Virginia has a program for that! Some call it "ballot harvesting". Someone can just come pick up that guy's ballot and make sure he "votes." To be fair, there are guidelines for ballot collection in Virginia. But since the first time we instituted "mail-in" ballots, then changed the law in favor of ballot collection, the Dems share of votes went up around 25% in Goochland. I would never accuse the Goochland Dems of cheating. But it would be fair to say that they have done a much better job legally collecting ballots to help their candidates.

Times have changed in Virginia elections. The focus needs to be about ballots, not votes. The constituents are competing



with big money donors for relevance in representation. But that's a problem once the candidate is elected. First we need to get them into office by having enough ballots to win. Once they're in, we need to keep them accountable to us constituents who got enough ballots through and just hope there are enough wealthy donors affecting legislation on our side.

Goochland Administrator Presents Proposed Fiscal Year 2024 Budget

Goochland County Administrator Victor Carpenter presented a proposed All Funds Budget of \$138.7 million for Fiscal Year 2024 to the Goochland County Board of Supervisors on Tuesday, February 21st.



The proposed Fiscal Year 2024 Budget is a \$14.3 million or 11.5% increase from the Fiscal Year 2023 budget and would begin on July 1. The County General Fund budget at \$86.5 million represents a \$12.1 million or 16.2% increase from the current year.

Priorities for the Fiscal Year 2024 Budget include enhancing the highquality core services provided by Education and Public Safety. Total County planned investments in Education for Fiscal Year 2024 are

\$26.8 million, a 4.9% or a \$1.3 million increase in local funding for Schools over the prior year (not including Capital Improvements). The budget for Public Safety, a key focus area for the proposed budget, grew by \$3.5 million or 18.1% over the current fiscal year.


