Understanding the real problem with the School Board GCRC CHAIR BUDDY BISHOP

Understanding the heart of an issue requires a considered look past surface impressions. This is true for our local school board's recent predicament with how they manage student bathrooms. Historically, school systems have grappled with various challenges, from negotiating student lifestyles and social trends to confronting contemporary issues like bullying and dress codes. These instances and varied others are not novel, they have punctuated every era of American youth and demanded tailored administrative responses as time went on.

However, the crux of the issue at hand lies not in these tangible Social and cultural challenges, but in the board's approach towards communication with parents and community members. The crux of the matter lies in transparency, or the lack thereof.

As many in Goochland know, this issue came into stark relief when Angela Allen posed a simple, yet poignant question on Facebook: "Is this our communities' expectation?". She was referring to a controversial issue of male and female students going into each other's bathrooms. This is a new social and emerging cultural challenge and is not a point or position I'm interested in making here. The subsequent censure of Angela raised eyebrows and perhaps communicated a message the board hadn't intended. This wasn't a critique solely targeted at Angela. I suggest it includes the parents who were unhappy with the mismatch between the board's declared and actual approaches.

The matter, at its core, revolves around open dialogue and honesty. Branding the expression of legitimate safety concerns as complacency with serious issues such as violence, hate, racism, and transphobia isn't a productive response. Instead, it suggests a calculated shift of blame. Similarly,

failing to inform ahead of time both Angela and the new interim superintendent about the censure, only to subtly introduce it during the New Business section of the agenda after most of the meetings attendees had departed, reflects a deliberate lack of transparency.

The criticism should not be directed solely at Angela Allen for allegedly tarnishing the board's reputation. It seems more fitting to consider how the board's actions might have impacted on its own standing while trying to undermine hers. It is not my intention to be mirch the school board, yet it seems clear that their reputation has taken a hit.

Reflecting on the past, the case-by-case approach seemed fine to some at first. However, a more discerning view now suggests that such an approach may pave the way for undesirable incidents. The best way to regain public confidence is by establishing a comprehensive policy with significant input from local parents, rather than solely relying on the "edu-speak" and "wisdom" of the Department of Education.

Governor Youngkin's election win of the Governor's mansion stands as a pertinent example. His victory can be attributed to a resounding call from parents who felt marginalized by former Governor McAuliffe's implication that they shouldn't have a say in the curriculum taught to their children. This mobilized an otherwise likely passive electorate, and I expect we will participate and witness a similar trend this Fall, where the majority of the voters have every incentive to replace up to 80% of the school board in the upcoming November election.

In conclusion, the school board's approach to recent issues has sparked a call for change, a call for transparency. Though a resolution addressing these concerns wasn't passed by the board, in fact the resolution of censure they passed did the opposite, A positive resolution in support of Angela Allen was taken up by the Goochland County Republican Committee in their May business meeting and passed unanimously. As we move forward, it is my hope and intention that with Angela being joined by Karen Wirsing D2, Ellen Robinson D5, Meredith Moses D1, and Michelle Maxwell D4, we can collectively rebuild and re-establish a transparent, accountable school board that values and respects all the voices of its community.


